

## Oman Flake Graphite Refinery for Uley 2 Production MOU Signed with the Governorate of Buraimi, Oman

The Company is pleased to announce that its downstream technology partner, the Sunlands Pure Group (SPG) has signed a Memorandum of Understanding (MOU) with the Governorate of Al Buraimi, Oman. The MOU recognises the strategic importance of SPG's development of the large-scale graphite refinery and related supporting activities to be constructed in Buraimi, Oman. The development is planned within an extensive parcel of land exceeding 240 hectares in Buraimi, approximately 60 kilometres from the Sohar Port, Oman's main commercial port.
